Somali Disability Empowerment Network (SODEN) is deeply saddened about the brutal killing of the Chairperson of the disability groups in Baidoa, Mr. Sharif Mukhtar who was a wheelchair user. Mr. Mukhtar has been a very key prominent human rights activist who actively advocated for the rights of people with disabilities in the Southwest State of Somalia. He lived in one of the IDP camps in Baidoa town when the terrorist group, Al-Shabaab killed while he was at home with his family.
